Written Theory Curriculum discussion:

Committee (Lauren Schack-Clark, Mark Smidt, Marika Kyriakos, Judy Warner and Paul Whitley) met over the past year and discussed what needed revising and what was possible to revise. They looked over the current Oklahoma test and thought that it would be great to implement in Arkansas. It would cost us \$500 for the 3 series of tests or \$250 for 1 series of tests.

Would there be restrictions if we tweaked the Ok test after we pay for it. Lauren Schack-Clark will ask Ok to make sure about property rights.

Since Oklahoma test is level 1-13, should we add some primary levels (for level 1-2). Concern arose if level 3 is compatible with Arkansas level 1. Members noted the disparity in the levels. Members also noted the difficulty of the early levels for Oklahoma test.

Paul Whitley made a motion to adopt Oklahoma's written theory test as is and that Carolyn Setliff and Sharon Ard will re-write levels primary A and B. Also the committee will work to correlate the OK levels with the AR levels. ? seconded the motion. Motion passed. Thank you to the committee.
